


# ANNEXURE II

## Event Overview

### **BIZ QUIZ**

Biz Quiz is a competitive event designed to evaluate the participants' business acumen, entrepreneurial skills, and general awareness. The competition aims to test participants' knowledge of the latest trends, news, and innovations in the business world, while also testing their analytical and problem-solving skills. The competition typically comprises a series of multiple-choice questions and rapid-fire rounds that cover various business domains such as finance, markets, brands, personalities, current affairs, technology and much more. Participants are expected to answer questions quickly and accurately, demonstrating their ability to think on their feet and under the pressure of limited time.

### **COMPANY BOARD SIMULATION**

The Company Board Simulation is a captivating and riveting event that enables participants to delve into the realm of corporate leadership. This competitive event places participants in the shoes of high-ranking corporate executives heading various departments and challenges them to navigate through various crises that simulate real-life situations. The participants are expected to use their acute analytical and critical thinking skills to evaluate complex situations, identify potential risks and opportunities, and develop innovative solutions to be implemented. The teams will be selected based on their presentations in the online round. As a team, they must work collaboratively and seamlessly to manage the crises, at the same time preserve the company's assets, reputation and growth rate.

## **REGULÆ JURIS**

Regulæ Juris is a law-based competition which aims to provide higher thinking and judgement skills to the participants in legal matters. In this competition, the participants will get the opportunity to hone their skills in fictional scenarios based on real-life challenges faced in courts, for which they must give logical solutions. A real-world simulation of courts will allow participants to gain experience of being advocates and participate with a competitive spirit. In the initial stage (Lex Competere), participants will be given a case study/legal issue, based on which they will present their arguments via a video along with a PowerPoint Presentation. The competition will allow the participants to examine their comprehensive skills and also widen their horizons of judicial knowledge.

## **THE TRADERS' GAMBIT**

The Traders' Gambit is a stock market simulation that allows the participants to experience the challenges and excitement brought by buying and selling shares. The primary objective is to earn the highest return on investment by accurately predicting the stock market movements. Participants must demonstrate their knowledge and expertise in financial analysis, market research, and risk management to make informed investment decisions. To make informed decisions, they must consider various factors, such as the company's financial performance, industry trends and competition. In the initial online round, the students will be provided with a case study, based on which they'll have to prepare a problem-solution analysis (PSA) document.

# ANNEXURE III

## General Rules

- Separate WhatsApp groups of the team leaders will be created once the registrations have been closed.
- The teacher-in-charge must accompany the students on both days.
- Students must be in their **respective school uniforms** and carry their **school ID cards**.
- All participants must report to the event venue as per the timings specified in the itinerary. The dress code specified in the itinerary must be followed on both event days.
- Judges' decisions will be **final and binding**.
- Any team caught cheating or using any unfair means will be **disqualified** at the discretion of the authorities.
- Bhavan Vidyalaya Chandigarh **will not be responsible** for any loss/ damage of any property of any participant during the event. Mobile phones should be deposited with the accompanying teacher before the event.
- Any participant causing damage or vandalising any property of the organising school will be **reported and charged** as per the damages incurred.
- There will be zero tolerance towards any form of verbal, physical abuse and/or sexual harassment. Any participant found indulging in the same will be reported to their respective school authorities and if the need arises, disciplinary action will be taken against them.

# ANNEXURE IV

## Rules, Regulation and Fee

### BIZ QUIZ:

- 1) Each school may register only **one team** comprising of two members.
- 2) The participation fee for all registered participants is **₹500** each inclusive of a participation kit, tea and lunch, to be paid latest by **23<sup>rd</sup> May 2023** (as per details in **Annexure V**)
- 3) Biz Quiz shall comprise the following two rounds:
  - a) Qualifying Round (Pen & Paper OFFLINE) on **4<sup>th</sup> August 2023**.
  - b) 8 teams shall qualify for the final round to be held on **4<sup>th</sup> August 2023**.
  - c) All the other teams not qualifying for the final round will be required to attend the rest of the event

### COMPANY BOARD SIMULATION, THE TRADERS' GAMBIT, THE SHARK TANK SHOWDOWN, REGULÆ JURIS:

- 1) Each school may register a **maximum of 3 teams**.
- 2) The detailed schedule of the above events is listed in **Annexure I**.
- 3) Each of these events shall have an **online qualifying round** for selection for the final round.
- 4) There is a **registration fee of ₹100 per participant** for the initial **online round** to be paid latest by **25<sup>th</sup> May 2023**. **The deadline for online submissions will be 15<sup>th</sup> July 2023**.  
**Results for the same will be announced by 18<sup>th</sup> July 2023**.
- 5) Teams selected for the final offline round are required to pay a registration fee of **₹400 per participant**, latest by **20<sup>th</sup> July 2023**, failing which, the next team shall be considered for the final round.
- 6) Payment is to be made as per the details provided in **Annexure V**.

## Payment Instructions

- 1) The registration of the team for the second round will be confirmed only when the due **amount has been deposited** and a **screenshot of the payment details** has been sent to the **convenors via WhatsApp** (details have been provided on **Page 1**).
- 2) The registration fee will be paid into **BVC's bank account** (details mentioned below).
- 3) The school will make a **combined payment** for all the participants of a particular event.
- 4) The fee should be paid after registering through the links provided in Annexure II. While making the payment, the participating school's name should be written along with the event in the following format: **school name, event name, no. of participating teams, and total amount**. The details should not exceed **30 characters**.
